Your duly filled and signed form (sections A-C) must reach us either via mail, fax or e-mail (Scanned copy) within 30 days of your statement date along with all the supporting documentation (The relevant statement copy duly marking the disputed amount(s) / charge slip / correspondence / cash receipt / postal receipts etc.).

After the lapse of 30 days from your statement date, it will be construed that all transactions posted in the statement are acceptable and are in order.
